
**Brief Reasons, if any:** *(Rule 59.02(2)(b))*

1. The applicant seeks to challenge legislation impacting Ontario Place. It seeks a date for an injunction. After discussion with the parties, it was agreed that it would be more efficient to address the application. A date has now been set for **July 19, 2024** to hear the application.
2. As an interim measure pending the conclusion of the hearing scheduled for July 19, 2024, Ontario agrees to the following until 6 pm on July 19, 2024, with respect to the work at Ontario Place:
  1. Ontario will not cause or permit any permanent destruction of any trees, shrubs or buildings at Ontario Place.
  2. If unforeseen circumstances require that the work described in para. 1 must be done, for example to prevent a serious risk of harm to any person's health, Ontario will make best efforts to provide advance notice to the Applicant and the Court.
3. In respect of a schedule, this Court orders that:
  - 1) Application record is due on July 3, 2024;
  - 2) Responding record, if any, due on July 8, 2024;
  - 3) Reply record, if any, due on July 10, 2024;
  - 4) Cross-examination to be completed on July 11, 2024;
  - 5) Applicant's factum due by July 15, 2024 at 4 pm; and
  - 6) Respondent's factum due by July 17, 2024 at 12 pm.
4. The application can be heard on July 19, 2024, for one full day.
