NOTICE OF APPEAL

The appellant, Ontario Place Protectors, appeals to the Court of Appeal from the decision of the Superior Court of Justice, located at 361 University Avenue, Toronto, ON, dated July 26, 2024,

THE APPELLANT ASKS:

- 1. For a declaration that (a) s. 17 of the *Rebuilding Ontario Place Act*, 2023, S.O. 2023, c. 25, Sched. 21 (the "ROPA") is of no force and effect as it breaches section 96 of the *Constitution Act*, 1867, and (b) ss. 9, 10, 11 and 17 of the ROPA should be declared a breach of public trust;
- If necessary, a stay and/or injunction prohibiting the respondents from further implementing the ROPA;
- 3. The appellant's costs on a substantial indemnity basis; and
- 4. Such further and other relief as counsel may advise and this Honourable Court may permit.

THE GROUNDS FOR THE APPEAL ARE:

- 5. The Superior Court of Justice erred in law:
 - (i) by misinterpreting and/or misapplying the law regarding standing in this matter;

(ii) by misinterpreting and/or misapplying the law regarding statutory interpretation in

relation to s. 17 of the ROPA;

(iii) by misinterpreting and/or misapplying the law regarding s. 96 of the Constitution Act,

1867 in relation to s. 17 of the ROPA;

(iv) by misinterpreting and/or misapplying the law regarding the doctrine of public trust in

relation to ss. 9, 10, 11 and 17 of the ROPA;

(v) by misinterpreting and/or misapplying the law regarding the granting of a stay in relation

to the foregoing;

6. Rule 61 of the Rules of Civil Procedure; and

7. Such further and other grounds as counsel may advise and this Honourable Court may permit.

THE BASIS OF THE APPELLATE COURT'S JURISDICTION IS:

8. Subsection 6(1)(b) of the *Courts of Justice Act*; and

9. Such further and other grounds as counsel may advise and this Honourable Court may permit.
